Are you also concerned for the safety of you and your family in your own neighborhood? Are you tired of the SD Police Department virtually ignoring the problems in your neighborhood? You can get involved and make a difference. Prostitution, public drunkenness in the parks where our children (should be able to) play and using our public lands for open campfires, cooking fires and as a toilet facility cannot be tolerated by law abiding residents.

You may have already heard of recent (Oct 3) video taped evidence of prostitution openly happening in broad daylight in your neighborhood (see pictures below). You may contact every one in the list below to firmly demand immediate action is taken to rid your community of activities such as public prostitution and drunkenness, migrant squatters using your neighborhood as a toilet, starting open fires and any other activities you find objectionable.
